TERMS AND CONDITIONS APPLICABLE To Springwood Sports Club's Car and Cash Giveaway:

The promotion name is Springwood Sports Club's Car and Cash Giveaway. The promotion is authorised under NSW Permit No LTPS/19/35278

1. The Promoter is Mingara Recreation Club Ltd ABN 81 001 662 648.

2. The Promotion will take place at Springwood Sports Club, details being:

3. Springwood Sports Club's Car and Cash Giveaway is only open to current financial Ordinary, Special, and Life members of Springwood Sports Club, Springwood (the Club) only. However, the Promotion is not open to any member whilst their membership is suspended or during periods of partial or full self-exclusion. In addition, Provisional members can accrue but not redeem tickets until such time as their membership application has been approved in the usual manner by the Club's Board. To enter this promotion members must be 18 years and older.

4. Important conditions apply on the Bonus Prize see clauses 35 to 40 for further details. At each weekly draw one (1) chance at claiming the Bonus Prize is made available but this chance may not be claimed.

Promotional Period

5. The promotional period commences on and from 08:00 hours Monday 1 July 2019 and concludes with the last Major Draw on Sunday 28 June 2020.

6. There will be One Hundred and four (104) Weekly Minor Draws, Twelve (12) Semi-final Draws, and Twelve (12) Monthly Draws as stated in these conditions.

Promotion Entry Entitlements

7. A member is entitled to one (1) ticket in the Promotion for each one hundred (100) Reward Points which the member spends with the Club or with any participating outlet on the Club's licensed premises.

8. A member is also entitled to one (1) ticket in the promotion by swiping their membership card at any of the Membership Kiosks located throughout the Club's premises. A member is only entitled to one (1) such ticket each day (00:00 hours to 23:59 hours).

9. A member may also be allocated bonus tickets, up to one hundred (100) tickets per occurrence, throughout the promotional period by participating in digital and in store promotions. These include but

are not limited to attendance at shows and events, the completion of online competitions and surveys and random swipe bonuses issued through Springwood Sports Membership Kiosks.

10. Multiple tickets are permissible.

11. A member entitled to a ticket (s) in the Promotion in the circumstances outlined, must initiate the redemption of tickets into entries to be eligible into the promotion minor, second chance and monthly draws. A member can only initiate the printing of a voucher at one of the Membership Kiosks within the Club's premises. On each occasion, the voucher issued will reflect entry/entries to which the member has become entitled since last initiating redemption into the draw. This voucher will show the member's number of entries have been recorded and acknowledged. However, the binding evidence of an entry is the database record in the Club's relevant computer system, and not any printed voucher.

Minor Draw Details and Procedures

13. There will be One Hundred and four (104) Minor Draws, commencing on 1 July 2019, continuing every Wednesday and Sunday until the last minor draw on Sunday 28 June 2020.

14. For any Wednesday Minor Draw, rights of entry cease to accrue from 07:00 hours on the day of the Draw. Members must initiate entry/ies for any right of entry no later than 18:30 on the day of the Draw.

15. For any Sunday Minor Draw, rights of entry cease to accrue from 07:00 hours on the day of the Draw. Members must initiate entry/ies for any right of entry no later than 17:00 on the day of the Draw.

16. For each Wednesday Minor Draw, on the day of the Draw commencing at approximately 19:00 hours, (four) 4 ticket numbers and corresponding member names will be drawn one by one and from the Club's eBet and/or BSG computer systems. As each member name is drawn it will be announced via the Club's PA system. For each Sunday Minor Draw, on the day of the Draw commencing at approximately 17:30 hours, (four) 4 ticket numbers and corresponding member names will be drawn one by one and from the Club's eBet and/or BSG computer systems. As each member's name is drawn it will be announced via the Club's PA system.

17. The member must be on the Club's licensed premises¹ at the time of the first announcement of the member name and membership number has been made to be eligible to claim the prize.

18. The announced member must present themselves at the designated promotional stand within the Club's premises within 4 minutes of their name being called to claim a prize in the Minor Draw, otherwise the

announced member is not entitled to a prize. In that case a redraw will take place. This process will be repeated until the announced holder of the Four (4) drawn tickets have duly presented themselves and been acknowledged. The Club in its discretion may adjourn the process to continue at the next Minor Draw date, if all prizes are not duly claimed by 22:00 for a Wednesday Minor Draw or by 20:30 for a Sunday Minor Draw. In the event prizes are not claimed at the final Minor Draw (being Sunday 28th June 2020) then the draw will continue until all prizes are claimed. Although Four (4) numbers will be drawn, a single member may be the holder of multiple drawn entries.

25. The announced member must present themselves at the designated promotions stand within the Club's premises within four (4) minutes of their name being called to claim a prize of \$50 cash and a place in the Monthly Major draw, otherwise the announced member is not entitled to a prize. Monthly Major Draw

26. The Monthly Major Draws will take place on the last Sunday of each month, namely 28 July 2019, 25 August 2019, 29 September 2019, 27 October 2019, 24 November 2019, 29 December 2019, 26 January 2020, 23 February 2020, 29 March 2020, 26 April 2020 and 31 May 2020, 28 June 2020.

27. The Monthly Major Draw will occur after the Second Chance draw at approximately 19:30.

28. The only entrants in a particular Monthly Major Draw are the finalists resulting from each of the weekly Minor Draws held since the last Monthly Major Draw, together with the Second Chance Draw winners. A single member may be the holder of multiple drawn entries.

29. All Monthly Major Draw finalists must attend the designated promotional display between 18:00 and 18:45 on the day of the draw in order to confirm their attendance for the Monthly Major Draw and to claim their \$50 prize.

Bonus Prize Chance Draw

35. At each Weekly Draw one (1) of the eight (8) prizes available is a chance at the Bonus Prize. The Bonus Prize, is not a guaranteed prize as part of this promotion. The Bonus Prize will be on display at the promotional area, and full details of the Bonus Prize will be available at Springwood Sports Club's Reception Desk and Springwood Sports Club's Website. The first Bonus Prize is a Car, valued at less than \$20,000. The prize includes; on road costs (CTP Insurance, Private Registration, Stamp Duty and GST). 38. There will be fifty (50) wedges on the wheel, containing the following prizes;

 - 42 x \$50 Prize
39. For the spin to be valid it must complete three (3) x 360 degree revolutions and land completely on a prize, if a spin does not make three (3) complete revolutions of the wheel or lands in between One (1) prizes on a spoke the spin will be void and needs to be re spun.
40. The Club in its discretion may adjourn the process to continue at another advertised day and time, if all prizes are not duly claimed by 22:00 hours. This is subject to approval by NSW Office of Liquor, Gaming and Racing.

Maximum Promotion Prize Values for Weekly, Second Chance and Monthly Major Draws

Proof of qualification and payment of prizes

42. A member claiming a prize must identify themselves and prove their identity and eligibility to the reasonable satisfaction of the Club, in order to participate or for a prize to be awarded to them.
