# **TERMS AND CONDITIONS**

## APPLICABLE TO SPRINGWOOD SPORTS CLUB'S CASH GRAB PROMOTION:

The promotion name is SPLASH INTO CASH. The promotion is authorised under NSW TP/03668

- 1. The Promoter is Mingara Recreation Club t/as Springwood Sports Club ABN 81 001 662 648.
- 2. The promotion is only open to current financial members and provisional members of Springwood Sports Club.
- 3. Members who are either suspended or self-excluded are not eligible to participate or claim a prize in this promotion. Members who have let their membership lapse past their due month are deemed un-financial and are not eligible to participate or claim a prize in this promotion.
- 4. Members of other registered clubs that encompasses the Mingara Leisure Group are not eligible to participate or claim a prize in this promotion.
- 5. The Ebet Random Draw System will be used to select membership numbers from the membership database. All membership numbers produced by the Random Draw System will be verified against the Club's current membership database to determine the eligibility of the number drawn.

## WEEKLY DRAWS

- 6. Weekly draws will commence on Friday 06 June 2025 and run each Friday for 4 weeks with the final draw on Friday 27 June 2025. There will be 12 draws in total. 3 draws held each Friday.
- 7. To enter, members must either register at one of the Reward Kiosks in the club by swiping their membership card or have their card in a gaming machine. Entry will open at 4pm each Friday during the promotional period and will close each Friday at 7pm during the promotional period. Members are eligible to receive only 1 entry per draw night.
- 8. The prize maximum for each draw will be \$5,000 cash. This amount of cash will be contained in a cash grab machine. The denominations are as follows:
  - - \$100 x 16
  - - \$50 x 32
  - - \$20 x 36
  - - \$10 x 72
  - o  **\$5x 72**

- 9. One membership number will be drawn from the database of registered entries at 7, 7:30 and 8 pm each Friday during the promotional period. That membership number and corresponding member's name will be announced via the Club's PA system. The announced member must be in attendance within the Club's premises<sup>1</sup> and present themselves at the area designated for the conduct of this promotion within 4 minutes of their name being called to claim the prize, otherwise the announced member is not entitled to the prize and the prize is not awarded. The Club's premises are as determined by the Club in its discretion and comprise the licensed club building and designated outdoor areas (namely outdoor gaming, smoking areas but excludes the function rooms if in use for a private event at the time of the draws). The Club's car parks, bowling greens and outer building detached from the main club building do not form part of the Club's premises for the purposes of Club promotions.
- 10. If not duly claimed at the 7pm draw, a second draw will be conducted at 7:05pm. The process will be repeated until a winner is found and verified. This will be the action held at each of the 3 draw times until a winner is selected. The Club in its discretion may adjourn the process if a winner is not identified by 10pm.
- 11. Once a member presents themselves and are in compliance with the conditions of the permit, the member will partake in the promotion.

- 10. The member will be asked to enter the cash grab machine with a carry bag. Once inside and ready, the member will have 30 seconds to grab as many cash notes as they can and place them in the carry bag. The machine will automatically cease blowing after 30 seconds at which time no further cash can be collected by the winner.
- 11. Notes cannot be picked up from the floor or the inside panels of the cash machine. The member must only use their hands to grab the notes and must not use their clothing to hold or collect notes. The member may use their feet to dislodge notes pooling on the cash machine floor.
- 12. These rules will be explained to the member prior to entering the cash grab machine and will also be in writing on the side of the cash grab machine. Once the 30 seconds are up, the member will be asked to exit the cash grab machine and present the carry bag to a Springwood Sports Club team member. The team member will count the notes in view of the member and present the winning total to the member. The member must sign the prize declaration form.
- 13. Where the rules for collecting notes are deemed to have not been adhered to, the game will be stopped, the rules will be explained again to the member, any collected money placed back in the cash machine and the clock will be reset. The member will have one further opportunity to participate in the promotion in accordance with the rules, otherwise the prize is forfeited.
- 14. All entries in each night's Cash Grab database will be removed to start fresh for the following Friday's draw. The cash grab machine will be replenished with \$5,000 between each draw.
- 15. Prizes will be paid in cash.

## GENERAL TERMS AND CONDITIONS APPLICABLE TO ALL CLUB PROMOTIONS

1. The following persons are not eligible to participate in the promotion or win:

(a) [*Club officers; executives and families; other employees*] - Club directors or auditors; Club executives (and the immediate family of any executive); other Club employees;

(b) [*Contractors directly involved in the promotion, and families*] - Officers and employees of suppliers or contractors to the Club, who are directly involved in any aspect of the promotion (and the immediate family of any of them);

#### (c) [People who work on the Club's premises]

Persons whose usual place of work is within premises owned or leased by the Club, who are employed by any of the licensees or lessees of the Club;

#### (d) [People working at the Club at the time]

Persons employed by any other supplier or contractor of the Club who at or about the time of a particular draw, are on the Club's premises in that capacity as such an employee.

- 2. Information on how to enter forms part of the promotion conditions.
- 3. The Club's promotional areas (for announcements of all draws) are as determined by the Club in its discretion. Certain areas within the main club building are excluded including function rooms if in use for a private event at the time of the draws. The Club's car parks, bowling greens and outer building detached from the main club building do not form part of the Club's premises for the purposes of Club promotions.
- 4. The Club may require a winner to sign a legal acknowledgment, release and receipt in conformity with these conditions and in a form reasonably required by the Club, in order to be paid a prize.
- 5. The Club in its reasonable discretion may (but is not obliged to) cancel, suspend, terminate, modify or adjourn the promotion or any or all draws or any or all processes for the selection of any winner, where circumstances unexpected by the Club arise in relation to the promotion or a draw. Unexpected circumstances could include (but are not limited to) technical difficulties,

power outages, infection by computer virus, computer bug, tampering, unauthorised intervention, fraud, technical failures or errors, and any other unexpected circumstance beyond the reasonable control of the Club which corrupts or affects the administration, security, fairness, integrity or proper conduct as planned of the promotion. The Club's rights are subject to any direction given under any relevant legislation or in connection with any permit under which the promotion is conducted.

- 6. The Club's decisions in relation to the promotion may be made by the Club's CEO or his delegate or delegates from time to time (who may but need not be a Club executive), including decisions in relation to the appointment of a judge or judges in relation to the promotion or a particular draw or draws. The Club's CEO also may (but is not obliged to) appoint one or more scrutineers for a particular draw or draws or all draws or a prize process or all prize processes. Decisions by the Club's CEO, and subject to any countermanding decision by the Club's CEO also decisions by any such delegate or judge, are final. No such decision requires any consultation. No correspondence will be entered into in relation to any such decision.
- 7. The Club is not responsible for, and is not obliged to delay a draw or a process of selecting a winner because of any delay or impediment in connection with the admission of members or in the completion of entries to the promotion or in seeking to attend any draw or to attend the process of selecting a winner.
- 8. Further, the Club is not responsible for members being located in areas within the Club's premises in which PA announcements are not able to be heard, nor for the audible integrity of those announcements.
- 9. A prize will not be awarded or paid where in the Club's reasonable opinion it arises as a result of a machine or other technical malfunction.
- 10. The Club has no liability for acting on or promulgating any incorrect or inaccurate information, due to any error to any equipment or programming associated with or utilised in the promotion or any technical error or error by any third party.
- 11. Where the Club's decision is that a person claiming a prize is not eligible to participate or has not qualified to win the prize or, on the basis of these conditions, is not entitled to the award of a prize, the Club is entitled not to award the prize and the prize may remain at the same amount for another scheduled draw on that night.
- 12. Prizes are strictly not transferable or negotiable.
- 13. The collection, use and disclosure of personal information provided to the Club in the course of the promotion is subject to these conditions and is otherwise governed by the Club's Privacy Policy. Please ask for a copy of that Policy if you are not aware of its contents. Members not wishing to participate in automatic draws should notify the Club's CEO's office in writing as soon as possible.
- 14. If the Club in good faith awards or pays a prize to someone appearing to the Club to be the prize winner, then to the maximum extent permitted by law that award or payment fully discharges the Club from all liability to the actual prize winner in relation to that prize.
- 15. Tax and financial implications may arise from winning a prize and winners should seek independent tax and financial advice before accepting. The Club is not responsible for any such advice.
- 16. No member is required to participate. Participation in the promotion is solely at the option of individual members. Members should not participate unless they are satisfied that they completely understand the way in which the promotion operates and these conditions.
- 17. These conditions cannot be varied for an individual member.
- 18. The Club determines the designated clock from which draws are timed.
- 19. A person by claiming or accepting a prize agrees that the Club may use their name, suburb, photograph, image and likeness for the purpose of promoting the Club and agrees to cooperate with the Club to allow their photo to be taken for those purposes.
- 20. Neither the Club nor any of its officers, employees, contractors or agents, has any liability for any loss or damage of any nature or for injury or death, sustained in connection with the promotion or any prize, except any minimum liability which cannot be excluded by law (if any).
- 21. Members will be notified of this promotion through advertising in the Club's members' magazine, and/or posters and flyers displayed within the Club's premises, PA announcements, or by other means at the Club's discretion. All advertising material will contain the approved Permit Number.
