

The following Terms and Conditions are applicable to Springwood Sports Club's Guaranteed Car and Cash – Great Kia Giveaway:

1. The promotion name is Springwood Sports Club's Guaranteed Car and Cash – Great Kia Giveaway. The promotion is authorised under NSW Authority No. TP/03668
2. The promoter is Mingara Recreation Club Ltd ABN 81 001 662 648 trading as Springwood Sports Club.
3. The promotion will take place at Springwood Sports Club, 83 Macquarie Road, Springwood NSW
4. Springwood Sports Club's Guaranteed Car and Cash – Great Kia Giveaway is only open to current financial members of Springwood Sports Club. The promotion is not open to any member while their membership is suspended or they are not financial.
5. Members who are solely members other registered clubs within Mingara Leisure Group (Mingara Recreation Club, The Westport Club, Lantern Club and The Greens The Entrance), are unable to participate or claim a prize in this promotion.
6. There are conditions that apply to the major prize, a Kia Picanto car, currently on display at Springwood Sports Club (see 40 for more information).

Promotional period

7. The promotional period commences on Wednesday, 29 April 2026 upon completion of that evening's Car and Cash weekly draw. The first weekly draw of Springwood Sports Club's Guaranteed Car and Cash – Great Kia Giveaway takes place on Sunday 3 May 2026. The final date of the promotion is Sunday 28 June 2026 (the night of the Guaranteed Draw).

Promotion entry entitlements

8. A member can earn one (1) entry ticket in the promotion for each one hundred (100) Reward Points they spend within the Club
9. A member can earn one (1) entry ticket in the promotion by swiping their membership card at any of the Membership Kiosks at the Club every day from 00:00 (midnight) to 23:59.
10. A member may be given up to (a maximum of) 100 bonus tickets throughout the promotional period by participating in digital and in-venue promotions. These include but are not limited to attendance at shows and events, the completion of online competitions and surveys and random swipe bonuses issued through Membership Kiosks.
11. A member may have multiple entry tickets at each draw and may be called out for multiple draws as per the random number generation system outlined in multiple clauses below, starting at clause 16.
12. Entry into each draw is not automatic. A member with an earned entry ticket (or tickets) into the promotion must redeem them in the promotion's weekly, second chance and major draws. A member can only redeem their entry tickets at one of the Membership Kiosks within the Club's

premises. The record of the number of tickets redeemed is kept on the database record in the Club's eBet computer system, and not recorded by the member. It is up to the member to ensure that they have redeemed the desired amount of entry tickets for that draw.

13. Entry into the promotion can only occur during the promotional period as stated in clause 7.

Weekly Draw details and procedures

14. For any Wednesday Weekly Draw, a member must redeem their entry tickets no later than 18:30 on the day of the draw with no entry for that night's draw after this time.
15. For any Sunday Weekly Draw, a member must redeem their entry tickets no later than 17:00 on the day of the draw with no entry for that night's draw after this time.
16. For any Wednesday Weekly Draw, five (5) members will be called from 19:00, based on their entry ticket number range. The members names will be drawn one by one, from the entry ticket number range, across all entry tickets redeemed for that night's draw. The ticket number is selected using a random number generation system. As each member name is drawn it will be announced via the Club's PA system.
17. For any Sunday Weekly Draw, five (5) members will be called from 17:30, based on their entry ticket number range. The members names will be drawn one by one, from the entry ticket number range across all entry tickets redeemed for that night's draw. The ticket number is selected using a random number generation system. As each member name is drawn it will be called via the Club's PA system.
18. Any member called must be on the Club's licensed premises at the time their name is announced to be eligible to win any prize.
19. Any member called must make their way to the designated promotion area in the Club within four (4) minutes of their name being called to claim a prize in the Weekly Draw, otherwise the announced member is not entitled to a prize.
20. If any member called is not present at the Club, or does not make their way to the designated promotion area within four (4) minutes, a redraw will take place. Redraws will be repeated as necessary, until five (5) members have successfully made their way to the designated promotion area in the time allocated.
21. The Club may adjourn the redraw process to continue at the next Weekly Draw date, if all prizes are not claimed by 22:00 for a Wednesday Weekly Draw, or by 20:30 for a Sunday Weekly Draw. In the event prizes are not claimed at the final Weekly Draw, then the draw will continue until all prizes are claimed.
22. For each Wednesday and Sunday Weekly Draw, the five (5) members called who present themselves to the designated promotion area will select and turn one (1) of eight (8) spin discs. Five (5) of the spin discs will include prizes (outlined below), with the other three (3) spin discs asking the member to try again. In the case the member selects a 'try again' disc, they will be able to spin another disc until they claim a prize. The five (5) prizes available at each weekly draw are;
- a. 1 x \$200 cash
 - b. 1 x \$150 cash
 - c. 1 x \$75 cash
 - d. 1x \$50 cash
 - e. 1 x entry into the Guaranteed Kia Draw on Sunday 28 June + \$200 cash

Promotion Rules – Effective May 2026

23. At a weekly draw night, after each spin disc has been turned and revealed, it will stay turned and revealed for the remainder of that draw night, and will no longer be able to be selected by any other called member.
24. At the conclusion of the weekly draws on Wednesday 24 June 2026, there will be 16 finalists in the Guaranteed Draw night on Sunday 28 June 2026. One member may be the holder of multiple finalist entries.

Second Chance Draw

25. A Second Chance Draw will take place on the Guaranteed Draw Night on Sunday 28 June, 2026.
26. All entry tickets redeemed throughout the entire promotion are eligible to participate in the Second Chance Draw.
27. Four (4) members will be called from 18:30. The members names will be drawn two at a time from the entry ticket number range, across all entry tickets redeemed throughout the entire promotional period. The ticket number is selected using a random number generation system. As each member name is drawn, it will be announced via the Club's PA system.
28. Any member called must be on the Club's licensed premises at the time their name is announced to be eligible to win any prize.
29. Any member called must make their way to the designated promotion area in the Club within four (4) minutes of their name being called to claim a prize in the Second Chance Draw, otherwise the announced member is not entitled to a prize.
30. If any member called is not present at the Club, or does not make their way to the designated promotion area within four (4) minutes, a redraw will take place. Redraws will be repeated as necessary, until four (4) members have successfully made their way to the designated promotion area in the time allocated.
31. A single member may be the holder of multiple drawn entries.

Guaranteed Draw

32. The Guaranteed Draw will take place on Sunday 28 June, 2026 after the Second Chance Draw at approximately 19:30.
33. The twenty (20) finalists (one member may hold multiple finalist entries), will be the only entrants in the Guaranteed Draw
34. The twenty (20) finalists are from each of the weekly draws held throughout the entire promotional period, together with the four (4) Second Chance Draw winners. A single member may be the holder of multiple drawn entries.
35. All finalists must attend the designated promotion area between 18:00 and 18:45 on the day Guaranteed Draw in order to confirm their attendance for the Guaranteed Draw and to claim their \$50 prize.

36. Any eligible finalists who fail to present themselves to the Club between 18:00 and 18:45 will be disqualified. In this case a redraw will occur as part of the Second Chance Draws using the same format and will be repeated for each finalist not present.
37. At approximately 19:30 on the day of the Guaranteed Draw, the name of each of the eligible finalists will be announced via the Club's PA system. Each finalist must present themselves to the designated promotional area within four (4) minutes of their name being called in order to qualify eligibility for the prize. A finalist who does not present themselves within four (4) minutes is then disqualified from participating and is no longer eligible to win the prize.
38. The Club in its discretion may adjourn the Guaranteed Draw announcements or prize process to another time and day, if necessary because of any delay in completing the earlier Second Chance Draw.
39. From the finalists present, the winner of the Guaranteed Prize will be determined by the finalists participating in a game of chance according to the promotional theme determined by the Club. The particular way in which the game of chance is to be conducted will be explained to the finalists collectively and over the Club's PA system to the audience. The game of chance will then proceed and the first winner will be declared the winner of the Guaranteed Prize.
40. The Guaranteed Prize in this promotion is the Kia Picanto on display at the Club. The car will be available three (3) days after the date of the Guaranteed Draw, after being serviced and registered by Great Western Kia, Penrith.

Proof of qualification and payment of prizes

41. A member claiming a prize must identify themselves and prove their identity and eligibility to the reasonable satisfaction of the Club.

GENERAL TERMS AND CONDITIONS APPLICABLE TO ALL CLUB PROMOTIONS

42. The following are not eligible to enter the promotion: The Mingara Leisure Group Executive Team (and their spouses and immediate family), The Club General Manager (and their spouses and immediate family), club Team Members, Mingara Leisure Group Directors or auditors, contractors directly involved in the promotion (and their spouses and immediate family), employees of suppliers or contractors to the Club, who are directly involved in any aspect of the promotion (and their spouses and immediate family), other people who work on the Club's premises including the Club's onsite Business Partners, persons whose usual place of work is within premises owned or leased by the Club, who are employed by any of the licensees or lessees of the Club, persons employed by any other supplier or contractor of the Club who at or about the time of a particular draw, are on the Club's premises in that capacity as such an employee. Information on how to enter forms part of the promotion conditions.
43. The Club's licensed premises are as determined by the Club in its discretion and comprise the licensed club building and designated outdoor areas (namely outdoor gaming areas, the terrace and smoking areas). The Club's front door entry airlock, car parks, bowling greens and outer building detached from the main club building are not considered to form part of the Club's licensed premises for the purposes of Club promotions.
44. The Club's promotional areas (for announcements of all draws) are as determined by the Club in its discretion. Certain areas within the main club building are excluded including function rooms if in use for a private event at the time of the draws. The Club's car parks, bowling greens and outer building detached from the main club building do not form part of the Club's premises for the purposes of Club promotions.

45. The Club may require a winner to sign a legal acknowledgment, release and receipt in conformity with these conditions, in order to be paid a prize.
46. The Club in its reasonable discretion may cancel, suspend, terminate, modify or adjourn the promotion or any or all draws or any or all processes for the selection of any winner, where circumstances unexpected by the Club arise in relation to the promotion or draw. Unexpected circumstances could include (but are not limited to) technical difficulties, power outages, technology outages (including computer viruses), tampering, unauthorised intervention, fraud, technical failures or errors, and any other unexpected circumstance beyond the reasonable control of the Club which corrupts or affects the administration, security, fairness, integrity or proper conduct as planned of the promotion. The Club's rights are subject to any direction given under any relevant legislation or in connection with any permit under which the promotion is conducted.
47. The Club's General Manager and/or the Promotion Team member running this promotion will appoint at least one scrutineer for any draw with a prize value greater than \$10,000.
48. Members wishing to be sure of entry should seek to complete transactions and to initiate ticket redemption as early as possible to reduce the risk of being excluded because of any shortage of service points or because of delay or crowding.
49. The Club is not obliged to delay any draw or selecting a winner because of any delay or obstruction with members seeking to redeem tickets.
50. The Club is not responsible for members located in areas of the Club in which PA announcements are not able to be heard, or for the audible integrity of any announcements.
51. A prize will not be awarded or paid where it arises as a result of a machine or other technical fault.
52. Prizes are strictly not transferable or negotiable.
53. The collection and use of personal data or information provided to the Club in the course of the promotion is subject to these conditions and governed by the Club's Privacy Policy. The Club's Privacy Policy is available at Reception or on the Club's website.
54. Members not wishing to participate in any automatic draws should notify the Club's General Manager in writing.
55. Tax and financial implications may arise from winning a prize and winners should seek independent tax and financial advice before accepting.
56. No member is required to participate. Participation in the promotion is solely at the option of individual members. Members should not participate unless they are satisfied that they completely understand the way in which the promotion operates and these conditions.
57. These conditions cannot be varied for an individual member.
58. The Club determines the designated clock from which draws are timed.
59. By claiming or accepting a prize, a person agrees that the Club may use their name, suburb, photograph, image and likeness for any marketing purposes including online/social media.

60. The Club, including its General Manager or team members, contractors or agents, have no liability for any loss or damage of any nature, or for injury or death, sustained in connection with the promotion, except any minimum liability which cannot be excluded by law (if any).
61. Members will be notified of this promotion through advertising within the Clubs Premises including a promotional display, website, social media and other digital mediums, PA announcements, or by other means at the Club's discretion. All marketing material will contain the approved Permit Number.
62. In the event that any prize is unavailable, the Club reserves the right to substitute a similar but not necessarily an identical prize, of equal or greater value.
63. The value of any prize (if stated) is only an approximate retail value in Australian dollars at the date the promotion is first launched.
